



"Small" cities have something to offer in terms of theoretical resources and renewing our understanding of urban life. Importantly, no city is reducible to one register in the representation of its essence. In *Writing Windhoek*, Tjirera makes an attempt to revivify the Capital city of Namibia and treat it as an idea meriting a closer examination and reflection. In illuminating the essence of Windhoek's cityness, this book traces its history of spatial segregation, an imprint that continues to define contemporary city life. The cultural memory of Windhoek is analysed as a way of accessing what is otherwise a not so obvious strand through which to understand a city that has escaped a sustained scholarly rendition. In his further layering of the city, Tjirera provides a portrait of Windhoek through urban fantasies, regimes of the legal, and how migration is implicated in shaping social heterogeneity and concatenations of various urban rhythms.



This book explores the development of the Rössing Uranium mine during the colonial and early post-colonial period. The book presents a detailed understanding of the strategies adopted by big business in response to changes in the political and economic environment in Namibia. It does so through a case study of big business and diplomacy in the establishment and operations of the Rössing Uranium mine under colonial rule and decolonisation. The focus of the book is ultimately on the public relations campaign which was adopted by Rössing Uranium in anticipation of the impending political change in Namibia.





The political, social and institutional settings in which archaeology was introduced in Namibia are examined in this study. The author re-examines the idea of archaeology as a scientific and objective discipline that could be practiced without input from the knowledge systems of local communities. He further problematises the use of archaeology as a discipline of knowledge of the land, as part of the extension of empire and governance over the people, in settings of deep and multiple colonialisms. The author therefore argues that archaeological practice was a form of ordering and governing people in a settler colony, thus, the decolonisation of archaeology must involve the work of undoing the structures of colonialism and include local knowledge. This book is a contribution to the fields of archaeology, history and heritage studies in Namibia.



Most research on the migrant labour system in Namibia under South African colonial rule emphasises its dehumanising aspects. In a complete contrast, this study highlights the social and ritual resources that contract workers and their families in colonial Ovamboland mobilised to provide forms of support and connection across great distances and absences. Based on extensive oral research, this study peels back the layers of intangible infrastructure that sustained migrant workers through all the stages of their contract, including observances around workplace deaths. This thesis vividly demonstrates the persistence of older practices that sustained the bonds of life, fellowship and family under stress, as well as adaptation to new colonial system such as the postal system.

Nature conservation is often framed as an ecological problem in need of repair. With both material and discursive dimensions, repairing things involves repairing people's orientation to those things. As such, nature conservation can be understood as a negotiation between different orientations to ecological problems. This publication seeks to understand the negotiation through trust, the analysis of which situates repair in a particular setting. Empirically, the book is structured around an encounter that unfolded over the course of a single day between white commercial farmers and experts belonging to various government departments, universities and an NGO working in a South African nature reserve. By moving through the situation sequence-by-sequence the author captures the relationship between trust and repair vis-à-vis the material forces that structured the situation, and the discursive methods that actors used to repair a degraded ecology.

The Ethnography of Faith is a detailed study of the ways in which people engage with and experience the religious in order to recognise and understand this suppressed voice of religiosity. In her analysis of the Lutheran church in the Soutpansberg of early 20th century South Africa, Caroline Jeannerat listens closely to how people describe their own faith and that of others in the archive: in accounts of work done, in texts written for mission publications, in songs composed for church services, in letters and newspaper articles, and in oral memories. A careful reading of this archive—for breaks, for misunderstandings and oppositions, for sentiments of agreement, praise, compatibility and claims of shared experiences—identifies negotiations of meaning which give indications of conceptualisations of faith that stand in distinction to those of the missionaries and their expectations.

The scarcity of conviviality in universities, within and between disciplines, and among scholars suggests that the position in and production and consumption of knowledge are far from neutral, objective, and disinterested processes. They are socially and politically mediated by webs of humanity, hierarchies of power, and instances of human agency. Given the resilience of colonial education in Africa and among Africans, endogenous traditions of knowledge are barely recognised and grossly underrepresented. Conviviality in knowledge production would entail not just seeking conversations and collaboration with and across disciplines in the conventional sense but also the integration of sidestepped popular epistemologies informed by popular universes and ideas of reality.



Civil society is one of several Western political and social concepts that have not traveled successfully to Africa. Revived in response to the search for democracy in Eastern Europe during the late Soviet era, Western donors promoted and funded new civil society organizations in subsaharan Africa, regarding them as an essential grounding for African democratization. Most of these new civil society organizations had little in common with African associational activity. One candidate worth serious investigation is the Buganda Kingdom Government. This organization violates most distinctions central to Western notions of civil society. Yet it continues to behave like a civil society organization. Its political and conceptual collisions offer guidance toward a useful notion of African civil society and understanding Ugandan politics.


In many instances, the colonial state has left a strong imprint on the postcolonial archive. In the National Archives of Namibia (NAN), for instance, it is difficult to locate pre-independence person-related records of the Black majority, while the same type of records of their light-skinned compatriots are easily accessible. This lecture discusses a substantial corpus of about 11'000 so-called "native estates," which previously was not accessible through finding aids. Furthermore, a substantial amount of estate files of migrants from other African countries were discovered. A more holistic view of the impact of labour migration might be achieved by digitising and linking such records across the boundaries.



The story of Windhoek's Old Location is one of African replacement and at the same time of creating home against all odds under the enforced, restricted living conditions of Apartheid. Being adjacent to the White centre of town, urban planning replaced the Old Location with the newly established township Katutura in the late 1950s. Many residents refused to be re-located. Escalating protest resulted in deadly clashes on 10th December 1959 when the colonial police opened fire on unarmed residents. At least 13 were killed and more than 40 recorded as wounded. After years of forced removal, the Old Location was officially closed in 1968. This book contributes to a commemorative culture of a crucial place and space during a formative time in Namibia's history. The captivating photographs by the German photographer Dieter Hinrichs, who documented social events and everyday life in the Location between 1959 and 1960, are essential. Many are published here for the first time. They speak louder than words.





> This edited volume shows surprising similarities in labour history and its legacy in two different contexts: South African occupied Namibia and Switzerland in the second half of the 20th century. Both the apartheid state and post-war Switzerland established an exploitative migrant labour system. In the Swiss case migrant labourers came on seasonal contracts from poorer southern-European countries such as Italy and Spain and later Turkey or the Balkan states. In the Namibian case the sending areas of the migrant labour were defined as African reserves and later "independent" homelands, allowing the workers to be treated as foreigners by the state. Two systems aimed at fast-tracking economic growth and safeguarding the nations from crises by setting quotas of "imported" cheap labour to be lowered or increased according to the needs of the economy. In both cases migrant labourers had only very limited rights and they were marginalised or outright excluded from participation in public life and society in their places of work.







It was also a community paper for the Old Location, the African township in Windhoek, whose residents were threatened with forced removals. The paper was launched shortly after the shootings at the Old Location in December 1959. *South West News* was one of the few public documents representing African issues to Africans themselves, and to the colonial society in Namibia at large. This book makes *South West News* accessible again and examines its history and contents.



He returned in August 2003 to an independent Namibia intending to repeat the rite of passage for his generation, to drive on route B1/B2 from Windhoek to Swakopmund and back. A road trip into the Namib Desert. 14 Dry River Beds expresses his perceptions of this journey. David Jacobson collaged photographs that he had taken in the field with other, sometimes very personal objects, citations from texts, and other forms of image. Each art piece is identifiable by the photograph of a dried-out river bed and the accompanying sign bearing the name of the river. Each image can be traced back to its location on a map of the country.
